# Minutes

Motion: approve minutes. Passed without objection.

### **Treasurer's report:**

Celia working to clean-up regatta payment system. Will leave to her unless she needs board help.

Glen brought up issue of how to handle/finance boat repairs and suggested we have a discussion.

#### **Program Director's report:**

Membership should hit \$70,000 not counting previous payments that came in during December. LTR revenue is much higher than projected, possibly as much as \$4k more.

That being said, other costs have been higher, and we need to watch costs, as we're a bit over budget. We may need to postpone December rent payment again.

Status of rent for former PWR space rental currently unknown, may end up having extra costs.

Sydney suggested doing some more aggressive fund-raising in 2017. Peter expects to have some fund-raising targets soon. Current loans will be paid off this year, so we can consider purchases.

**Motion:** Approve revised budget from Peter. Approved without dissent.

No news on boathouse front.

Peter less worried about cost of Row for the Cure, but will be smaller. May be last year we do Row for the Cure, as Molly at PVRA has expressed an interest.

# **Regatta Planning Committee**

Specifically wanted to make sure help being distributed more equitably at Row for the Cure and Fall Classic. Peter is creating a "race committee" to help organize the regatta(s). Peter planning to spread knowledge around this fall.

# **Values and Expectations**
